MINUTES OF THE 27th ANNUAL GENERAL MEETING

1.0 Minutes of 26th Annual General Meeting

The minutes of the last AGM was circulated via email to all members prior to the meeting. No further comment was received. The minutes was confirmed and adopted.

2.0 Chairperson's Report

Chairperson Prof. Kaimin SHIH reported that it was not an easy year for HKWMA and everyone under the current pandemic. After the 25th Anniversary Forum took place on 26 September 2019, the Two-Coast Forum on Waste Management was organized in Xian on 27 to 28 September 2019 and our delegates shared the latest development of Hong Kong Waste Management with our counterparts. This year's forum attracted government officials, academics, professionals, and representatives from a variety of associations, institutes and businessmen in the region to come exchanging information on the new development of the waste management industries in their regions. HKWMA has published a focus article discussing on the Recycling of Plastic Waste in Hong Kong on Wasteline 2/2019. It has further emphasized the impact of plastic waste in the global waste management community and also reported the development details in Hong Kong. Prof. Kaimin SHIH attended the consultation video conference for 2020 Policy Address and expressed support to the continuing effort of promoting the MSW charging scheme in Hong Kong.

Prof. Kaimin SHIH encouraged everyone to follow HKWMA updates on our internet homepage and through LinkedIn.

HKWMA had currently 283 members in total in 2020 with a very healthy financial situation for the association.

Members then approved Chairperson's report.

3.0 Treasurer's Report

The Financial Report 2019/2020 was made available for members at the meeting. Financial position as of 30 June 2020 was \$1,219,945. The report was approved without additional comments.
