### **COVID-19 Precautionary Measures:**

- Only guests who are **fully vaccinated**, i.e. have completed the COVID-19 vaccination course at least 14 days prior to the function date, will be allowed to enter the Club.
- In order to safeguard the Club members and staffs, guests who are **medically exempt will not be allowed to enter the Club.**
- Guests must **have their vaccination record on hand in either digital or printed form** so that the Club staff can scan their QR code by the government mandated record system when entering the individual outlets. **Guests who are not in possession of the necessary vaccination documents will not be able to enter the Club.**
- Guests must **scan the “Leave Home Safe” 1/F QR code using the “Leave Home Safe” mobile app when entering the function room.** This is a mandatory requirement by the government for all zones operating under Group D operation regulations.

### **Dress Code: Business Smart**

- Jeans, T-shirts, tracksuits, shorts, shoes for sports activities and flip-flops are not acceptable. No denim may be worn at any time in the Club
- The Club applies a strict dress code and have the right to refuse entry of any improperly dressed guests.
