MINUTES OF THE 28th ANNUAL GENERAL MEETING

1.0 Minutes of 27th Annual General Meeting

The minutes of the last AGM was circulated via email to all members prior to the meeting. No further comment was received. The minutes was confirmed and adopted.

2.0 Chairperson's Report

Chairperson Prof. Kaimin SHIH reported that it was not an easy year for HKWMA and everyone under the current unprecedented pandemic. It was disappointed that the AGM would have to be a virtual meeting instead of a physical meeting, and sorry to fail some of the members' expectations. Chairperson thank you for all the members' unfailing support to HKWMA and their understandings during this pandemic.

The first virtual 27th AGM was held on 28 September 2020 due to ongoing COVID19 social distancing restrictions. However, activities after January 2020 were severely impacted, and the HKWMA efforts had migrated to online media and platforms with articles being published in the newsletter to allow the association to offer views and opinions to the public of best practices. For example, the HKWMA remained actively engaged with Government and attended the recent online consultation for the Policy Address to highlight the importance of MSW Charging to reduce waste and the need to kick start legislations that have been put on hold prior to the Legco summer recess.

On 25 November 2020, HKWMA invited Mr. Harold Yip, Founder of Mil Mil Recycling Plant, to come to deliver an online seminar, introducing his journey of establishing and operating the Mil Mil Recycling Plant for treating drinks cartons.

On 21 April 2021, we were very pleased and honored to have the Secretary for the Environment, Mr. WONG Kam-sing, GBS, JP, to came to deliver the "Waste Blueprint for Hong Kong 2035" seminar at our virtual Spring Reception. Mr. Wong also had a rich interaction with our members in Q&A section.

On 28 May 2021, the Young Members Committee had organized a technical visit with 20 members to the processing plant of Billie Upcycling located in Tai Po Industrial Estate. Billie Upcycling

On 10 February 2021, HKWMA offered a statement of support on the Municipal Solid Waste (MSW) Charging Scheme to The Bills Committee on Waste Disposal.

HKWMA has published our newsletter “Wasteline”. This year we had a special article on how Hong Kong’s Chemical Waste Treatment Centre (CWTC) has prepared to take up this the COVID19 challenge in the clinical waste treatment was reported on our newsletter.

Prof. Kaimin SHIH encouraged everyone to follow HKWMA updates on our internet homepage and through LinkedIn.

HKWMA had currently 233 members in total in 2021 with a very healthy financial situation for the association.
