### **Programme Highlight**

O · PARK1, the first organic resources recovery center, locating at Siu Ho Wan of North Lantau adopts anaerobic digestion technology to convert food waste into biogas for electricity generation whilst the residues from the process can be produced as compost for landscaping and agriculture use.

O · PARK1 can treat 200 tonnes of organic waste per day, with 14 million kWh of surplus electricity can be supplied to the power grid per year, which is adequate for use by 3,000 households.
