MINUTES OF THE 26th ANNUAL GENERAL MEETING

1.0 Minutes of 25th Annual General Meeting

The minutes of the last AGM was circulated via email to all members prior to the meeting. No further comment was received. The minutes was confirmed and adopted.

2.0 Chairperson's Report

Chairperson Mr. Jude CHOW reported that HKWMA had a very successful year again. Rich and successful activities were held, including offering views on recycling industry development to Legislative Council, and organizing various conference/forum activities and technical visits. For examples, HKWMA delegates attended the ISWA in Malaysia in October 2018 and attended the EcoPro2018 in Tokyo in December 2018 and a very fruitful interaction with Kawasaki Government officials. This year the Two-Coast Forum on Waste Management was organized in Xian in September 2019 and our delegates shared the latest development of Hong Kong Waste Management with our counterparts. In November 2018, we received a group of Singapore delegation visiting Hong Kong and we invited them to Ecopark. Mr. Jude Chow was invited by RTHK as a guest speaker in November 2018 to share our views on recycling.

In May 2019, we had our traditional Spring Cocktail to meet our friends and members held at the Hong Kong Club. We invited Mrs Regina Leung of NGO Food for Good as our honourable guest to share their knowledge and experience with us.

And we just had the 25th Anniversary Forum "Municipal Solid Waste Charging: How will it impact Hong Kong" today with many guest of honours and speakers from different countries and business sectors to share new knowledge and experience.

HKWMA had currently 270 members in total in 2019 with a very healthy financial situation for the association. The HKWMA website continued to serve our members with the most updated information and event announcements. The association's newsletter "WasteLine" was updated to more widely broadcast the HKWMA activities.
